Minutes of the Dec. 14, 2019 Business Meeting were read and approved 6-0.

Colleen Nicholas began the meeting by reading a statement on standards of conduct for the business meeting and a review of the rules and regulations regarding conduct at the common facilities.

COMMITTEE REPORTS

Ecology – Ken Nowlin reported rain for December was 2½". The Chowan River was normal. Ecology conservation group met on 1/8/20. 5 members present: John & Kathy Lillard, Kitty Jarrell, Colleen Nicholas & Ken Nowlin. Several items were discussed including installation of a weather station on the pier, identifying trees in the park and water testing.

Public Works – Steve Mullen reported Rick Elkins cleaned up leaves and debris from clubhouse to the walkway of the office.

Rick also installed a security door for the drink machine to keep insects out and to keep anyone from reaching up inside.

The boat ramp is close to complete. Travis has done an excellent job.

Building Control – Chuck DeMoulin reported that 2 letters were sent to property owners regarding accumulation of trash and junk on the property.

Treasurer – Brenda DeMoulin reported that total income May through Dec. was \$97,524.50. Expenses for the same period was \$84,828.64 which included \$11,000 for the boat ramp which will be moved over from the reserve acct. Our checking account balance was \$16,618.51. Reserve balance is \$55,017.71. Vending machine income is \$943.15 with expenses of \$298.68 which includes \$186.68 for the security door. AMAs are \$8714.04 over budget. For the month of December total income was \$266 and expenses were \$17,742.48 which also includes a boat ramp payment. 123 members were in default in the amount of \$63,685.

President – Dee Spruce has requested to do more Zumba days. Zumba will now be every Monday @ 6 PM in the clubhouse beginning Jan. 27.

Thanks to Deb & Doug Ford for redoing the meeting signs. Thanks also to Catherine Gray and Becky Yaeckel for their contributions to the Nov/Dec newsletter.

The communications committee will meet next week to plan the Jan/Feb newsletter.

Secretary's Report – Dana Nicholas reported that the new office computer has been ordered from Dell. The Lonovo 5000 should be delivered by Feb. 12. The total actual cost is \$1380 (up from previous report) and includes Office 365 which will allow up to 5 devices to use Office from any location. It also includes installation and a 4 year warranty. A motion to approve the new purchase price is passed 6-0.

Neighborhood Watch – Dana reported that another resident has had their gas tank drilled into in order to steal the gas. The sheriff's office has been alerted as well as the name of a possible suspect. Product was stolen from some youths reaching up into the machine. As reported by Steve Mullen, a spring-loaded security door ordered from the vending company has been installed by Rick. The cost was

Legal – As acting legal director, Dana Nicholas reported that a new round of liens will be generated by the attorney's office for those members who are at least \$1000 behind in their AMAs. Several are new liens and some are second liens.

Parks & Recreation – Deb Reid reported the community clean-up held on 12/7 had 23 people attending and a total of 9.5 bags were collected.

The clubhouse was decorated for Christmas on 12/2 by Ken Nowlin, Barbara Sutton, Rick Elkins, Brenda DeMoulin and Bill & Brenda Robbins.

The December covered dish on 12/7, hosted by Brenda & Chuck DeMoulin, was attended by 52 people.

The dinner was visited by Santa & Mrs. Claus who gave out toys to all the children.

The clubhouse was rented 3 times during December.

Nominating Committee – Cathy Faulkner, nominating committee chair, announced the schedule for receiving resumes for those interested in running for the board.
